- 3. Treasurer's Report (Alden Clark)
  - Year to Date financials
  - Annual filing with the state (to maintain member in good standing) \$15 fee
- 4. Recreation Youth Center pedestrian safety concerns
  - RVCC to RYC walking routes map, RVCC to RYC walking routes aerial
  - City is currently planning a sidewalk immediately in front of the new center with crossing improvements (including a ped signal)
  - Bonnie attended Community Services Subcommittee to encourage additional sidewalk to connect to RVCS
  - Low Street is a bigger safety concern than just the location in front of the future Youth Center building, potential for the engineering study to cover Hale St to Graf Rd. Bonnie will communicate our continued support for this.
